

## NCA 14-177

**CLASSIFICATION: #43. OIL AND GAS** 

A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING NCA 13-266 (A LAW OF THE MUSCOGEE (CREEK) NATION CREATING NEW LAW IN TITLE 43, TITLED OIL AND GAS)

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. NEW LAW. The following new Law is hereby enacted:

Section 1-101. Findings. The National Council finds that:

- A. NCA 13-266 created the Muscogee (Creek) Nation Oil and Gas Department under MCNCA Title 43, entitled "Oil and Gas".
- B. The Muscogee (Creek) Nation Oil and Gas Department inherent authorities are to continuously monitor lease compliance, production reporting, damage assessments, lease negotiations, payment of royalties and other matters that relate to the harvesting of Oils and Gas from lands under the Jurisdiction of the Muscogee (Creek) Nation.
- C. The Department was established last year to accomplish the above goals; however, it was implemented gradually throughout the year as finding qualified employees specific to Oil and Gas took time to hire.
- D. The Department is requesting funds carry forward until fully expended to accomplish the goals set out in the newly established chapter and to lay the foundation of the Department's future accomplishments consistent with its authorities that relate to Oil and Gas.

**SECTION TWO.** <u>AMENDMENT</u>. NCA 13-266, Section Four. Appropriation. is hereby amended to read as follows:

SECTION FOUR. APPROPRIATION. The sum of Two Hundred Forty-Nine Thousand, Four Hundred Eighty-Seven and No/100 Dollars (\$249,487.00) is hereby appropriated from the Gaming Fund Account for the implementation of this Act. All unexpended funds appropriated by implementation of this Act shall carry forward until fully expended.
